However, survey results indicate that the playing field is leveling. As shown in Figure 8, about 43% of equipment and software finance volume came from bank lenders (down from 57% in 2017), while 33% came from manufacturers and vendors (up from 21% in 2017) and 12% from independents (down slightly from 16% in 2017).

SEFL leads the construction equipment finance market with a market share of approximately 32.7% in Fiscal 2017.
